1) Summary

This report on “USA Nonprofit Exempt Organization Financial History Analysis” is intended to provide the historical financial summary information of the USA nonprofit sector as management information for the USA nonprofit sector workers and the nonprofit sector researchers in community, government, and university.

According to IRS data as of July 11, 2017, the total income amount of USA nonprofit exempt organizations was \$3,942,261,036,477 (approximately \$4 trillion dollars). Total number of USA nonprofit exempt organizations was 1,648,368. Their total asset amount was \$6,256,812,296,029 (\$6.3 trillion dollars).

Total income (\$4 trillion) of USA nonprofit exempt organizations was 21.6 % of USA 2016 GDP (\$18.5 trillion). The USA Nonprofit Contribution to USA GDP is enormous economically. The nonprofit exempt organization data from IRS reveals sizable economic role of the USA nonprofit economy sector.

4.6 % in the income amount of nonprofit exempt organizations increased from 2015 (July 2015) to 2017 (July 2017) during the two years.

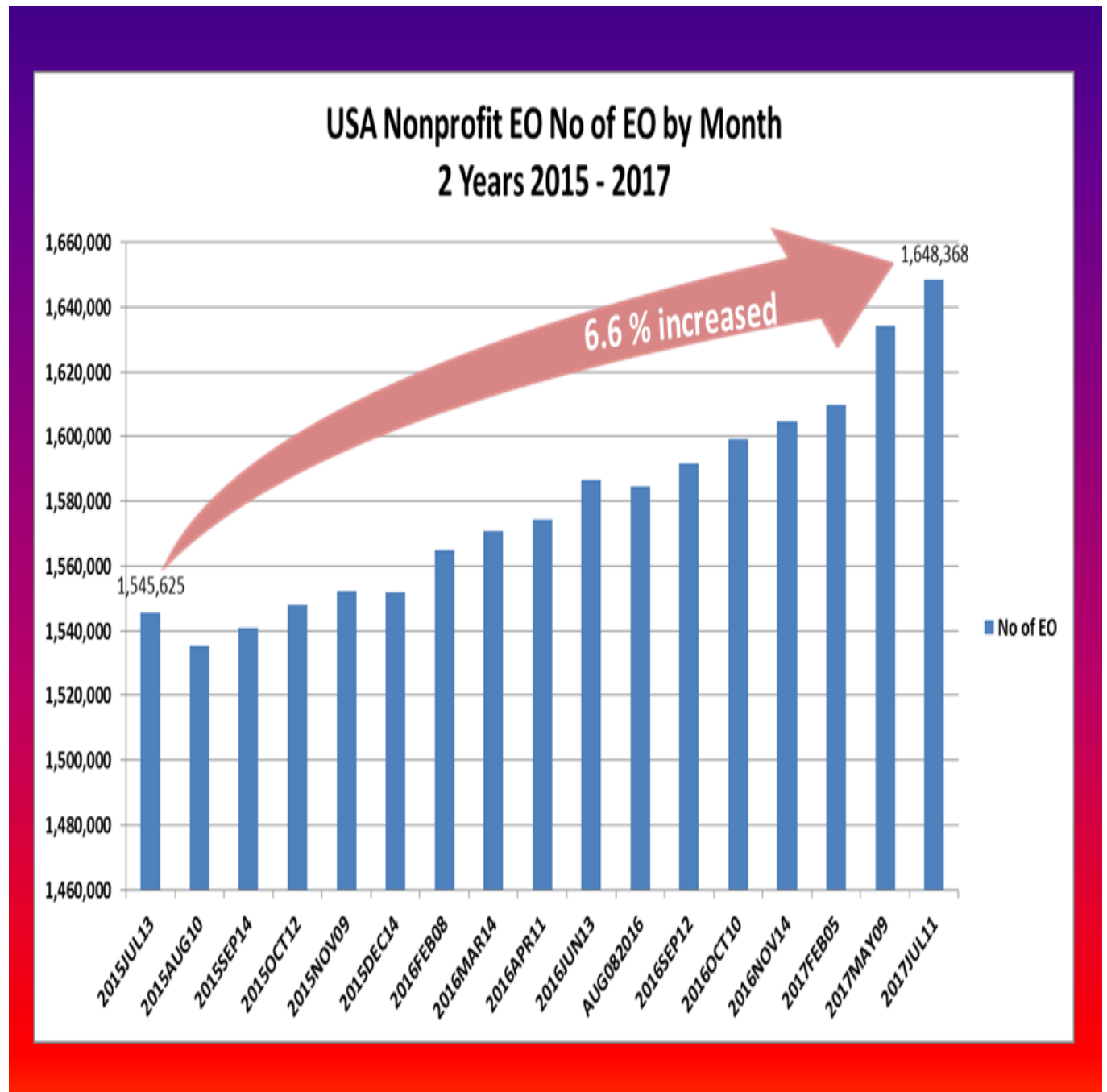
13.8 % in the asset amount of nonprofit exempt organizations increased from 2015 (July 2015) to 2017 (July 2017) during the two years.

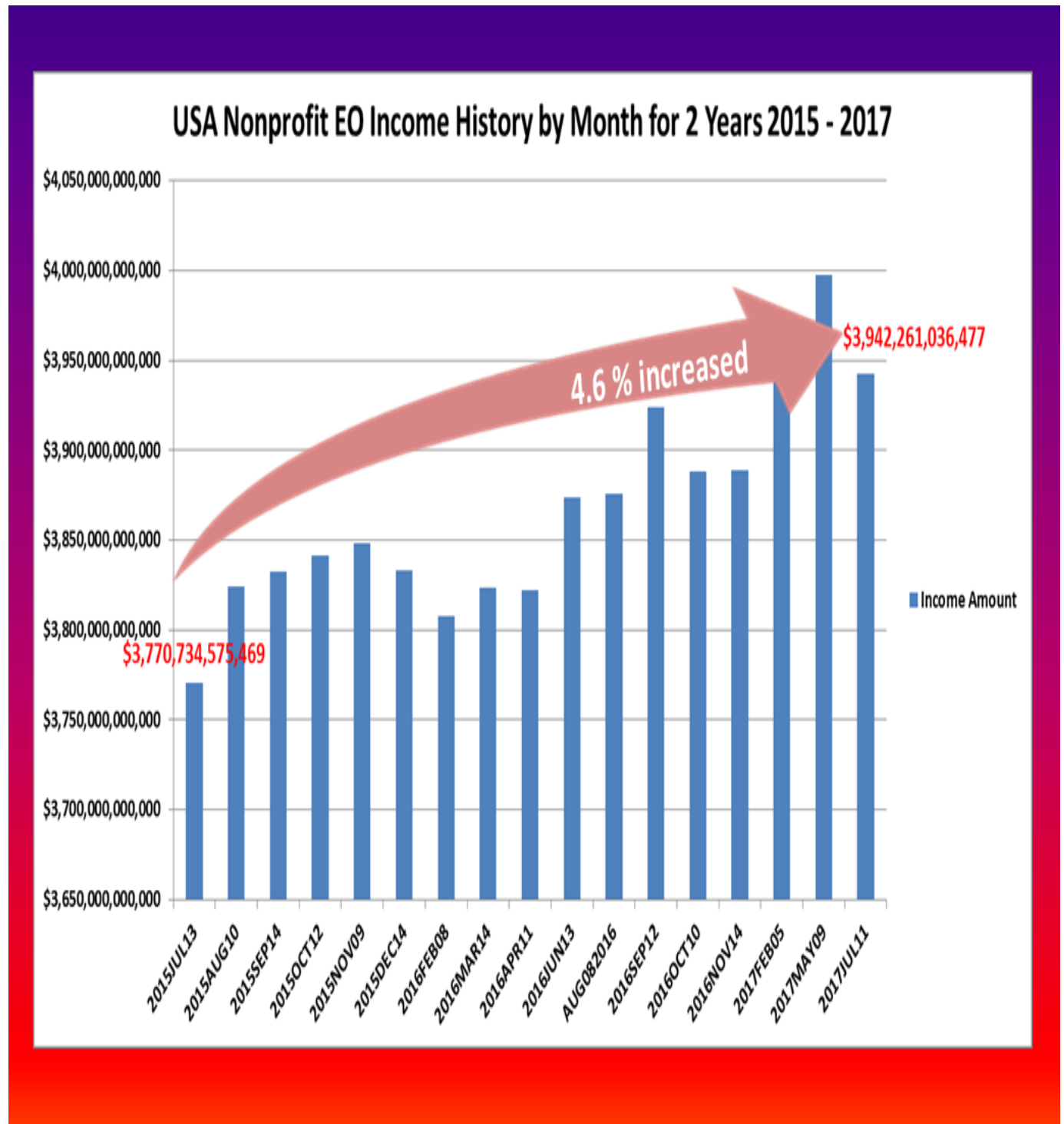

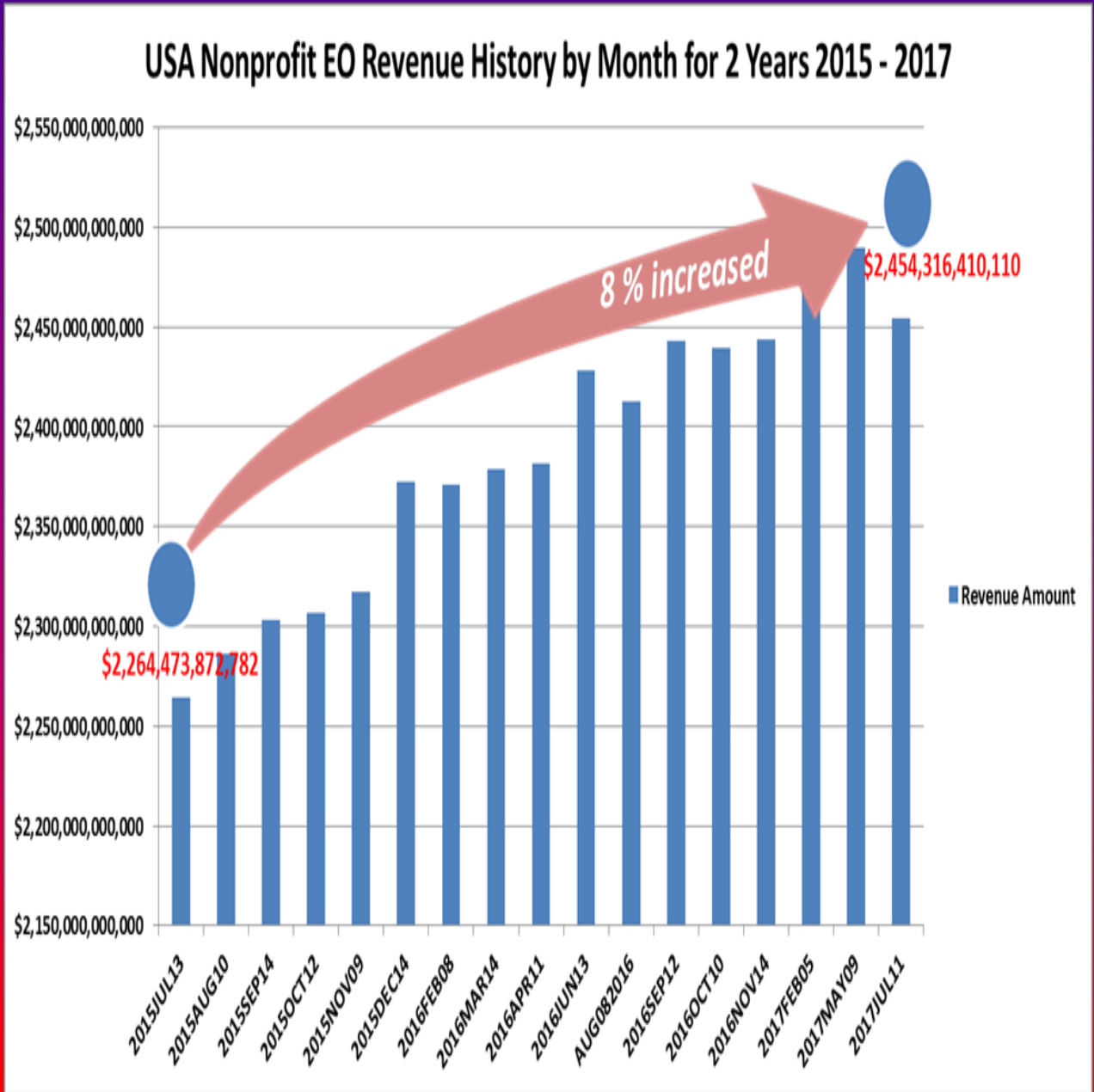
3) USA Nonprofit EO Count History Analysis by Post Month for 2 Years (2015 – 2017) as of July 11, 2017



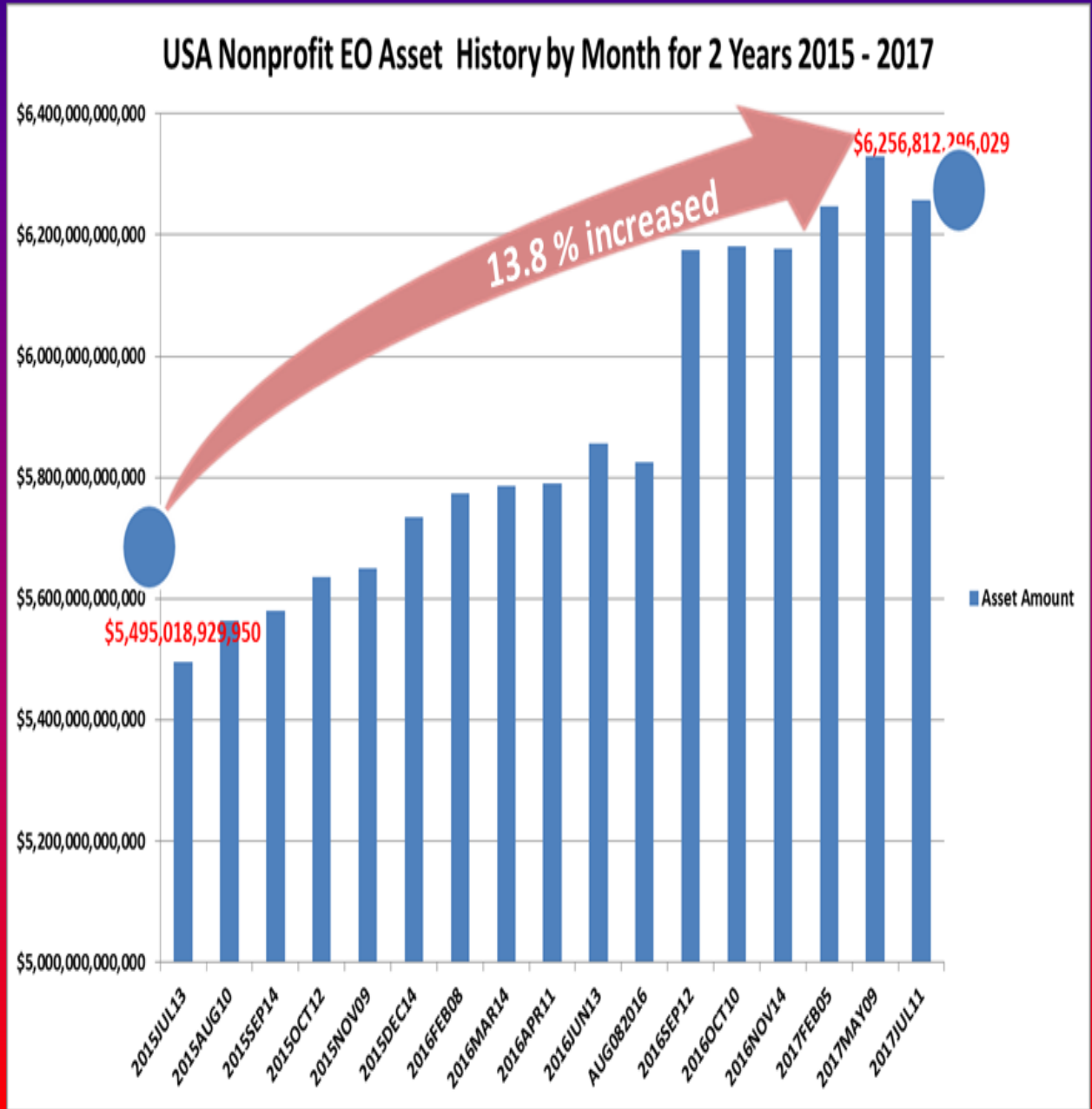
4) USA Nonprofit EO Income History Analysis by Post Month for 2 Years (2015 – 2017) as of July 11, 2017
